



## KELLER GRAND OPENING SWEEPSTAKES OFFICIAL RULES AND REGULATIONS

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

1. **PROMOTION PERIOD:** Monday, April 4, 2022, through Sunday, April 10, 2022
2. **ELIGIBILITY:** The Promotion is offered to anyone at least (18) years of age or older at time of entry.
